

DOES YOUR CHILD NEED MEDICATION AT SCHOOL?

Medications should be administered at home if possible. If it is necessary for a student to receive medications at school, parents must complete a Medication Consent Form. Any prescription medication will need a doctor's signature.

- Medication MUST be transported to and from school by parent or adult.
- Medication MUST be picked up by parent or adult at the end of the school year or it will be discarded.
- NO MEDICATION will be sent home with students. Medication must be in the original container and properly labeled. The Medication Administration Consent Form is found on our district website under the Families tab, then Health Resources tab.

Applications submitted before or after these dates CANNOT be accepted.


Open Enrollment is a program that allows parents to apply for their child to attend school in a school district other than the one in which they reside. Applications for open enrollment will be accepted from Monday, February 5, 2024 through 4:00pm on Tuesday, April 30, 2024. The preferred method of applying for open enrollment is through the on-line application at https://dpi.wi.gov/open-enrollment. SCHOOL CLOSING

Ashwaubenon Schools are in session unless a definite safety hazard exists due to weather. In the event of a major storm or extreme cold, school closing will be announced on local TV and radio stations along with our SCHOOL MESSENGER message system.

If severe weather develops after school has begun, the superintendent will make the decision of whether to hold school or close early. In the event that it is necessary to dismiss school early, the plan you sent to your child's teacher earlier this year will be followed. Please inform your child's teacher of any changes that may occur with that plan. Thank you.

ATTENTION YMCA FAMILIES: The YMCA Before & After School Program will NOT operate on days that there are 2 Hour Delays, Early Releases due to inclement weather or on days that After School Events have been canceled due to the weather.
