THE ASHWAUBENON SCHOOL DISTRICT ANNOUNCES THE AVAILABILITY OF THE REMEDIATION ADMINISTRATIVE RECORD FILE

Project Location: Ashwaubenon High School, 2391 South Ridge Road, Ashwaubenon, WI 54304

The Ashwaubenon School District ("ASD") announces the availability for public review of documents comprising the administrative record file for the selection of the remedial activity relating to the Ashwaubenon High School athletic fields. The documents are available at the the Ashwaubenon School District Offices at 1055 Griffiths Lane, Ashwaubenon, WI 54304. ASD encourages the public to review and comment on the documents and proposed remedial action.

The administrative record file includes documents which form the basis for the selection of the remedial activity at this site. Documents now in the administrative record file include, but are not limited to, preliminary site assessments and inspections, reports, test results, sampling data and various memoranda and communication with Wisconsin Department of Natural Resources ("WDNR"). Other documents could be added to the file as site work progresses. These additional documents may include, but are not limited to, technical reports, sampling data, comments and new data submitted by interested persons, communications from the Environmental Protection Agency ("EPA") and WDNR, and responses to comments. No further announcement of availability will be made.

Contamination at this site is associated with a historic fill site. Polychlorinated Biphenyls ("PCBs") were found in soil samples from the site in concentrations exceeding applicable nonindustrial residential contaminant levels ("RCLs") and the Toxic Substances Control Act ("TSCA") threshold. With the oversight of WDNR and EPA, the ASD has utilized risk based site assessment standards to develop a remediation plan. The remediation plan involves the capping of approximately 30,000 yards of green space. Prior to capping, the remedial action involves the contouring of soils as well as the excavation and proper disposal of certain impacted soils. The capping system will include geotextile, drainage and irrigation systems, 6 inches of clay and 6 inches of topsoil for seeding.

Public comments on the remedial activity decision will be accepted for thirty (30) days from the date this notice appears in print. A public meeting will be held to facilitate verbal comments on **Monday August 11, 2014 at 1:00 PM** at the Ashwaubenon School District Office in the Board Room. At the end of the thirty (30) day comment period a written summary of responses to comments will be placed in the administrative record file. Written comments shall be sent to:
