School Report Cards

Beginning in 2011-12, as part of the new state accountability system, the Department of Public Instruction (DPI) has produced report cards for every school in Wisconsin. These School Report Cards provide data on multiple indicators for four Priority Areas:

- **Student Achievement** – performance on the WKCE and WAA-SwD in reading and mathematics
- **Student Growth** – improvement over time on the WKCE in reading and mathematics
- **Closing Gaps** – progress of student subgroups in closing statewide gaps in reading and mathematics performance and/or graduation rates
- **On-track and Postsecondary Readiness** – performance on key indicators of readiness for graduation and postsecondary pursuits, whether college or career

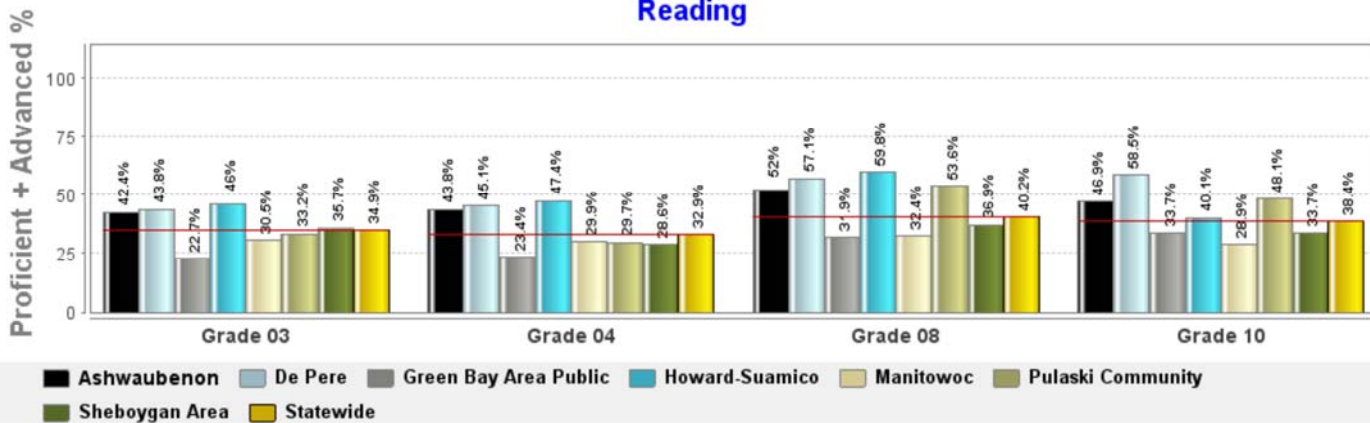

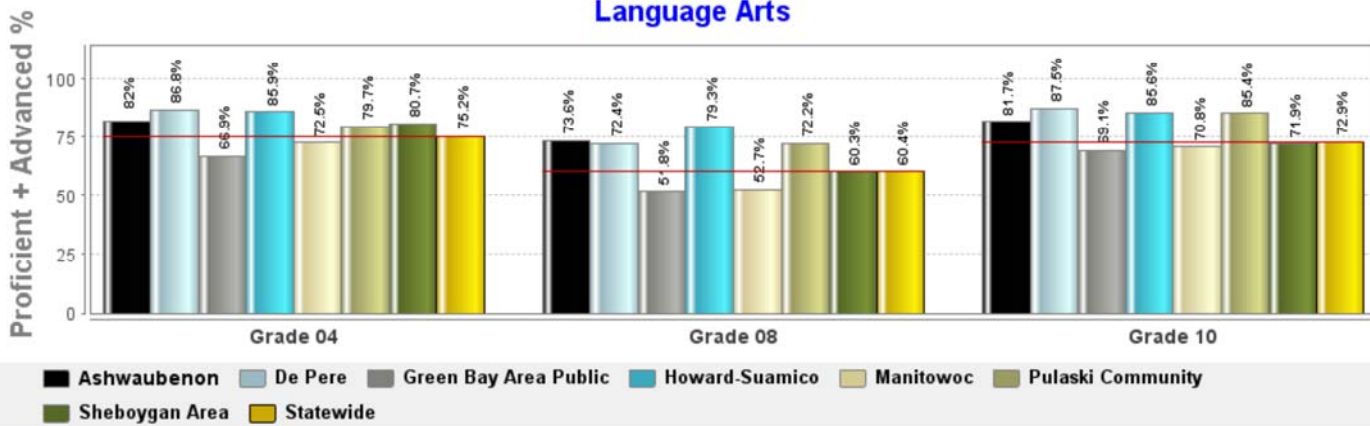

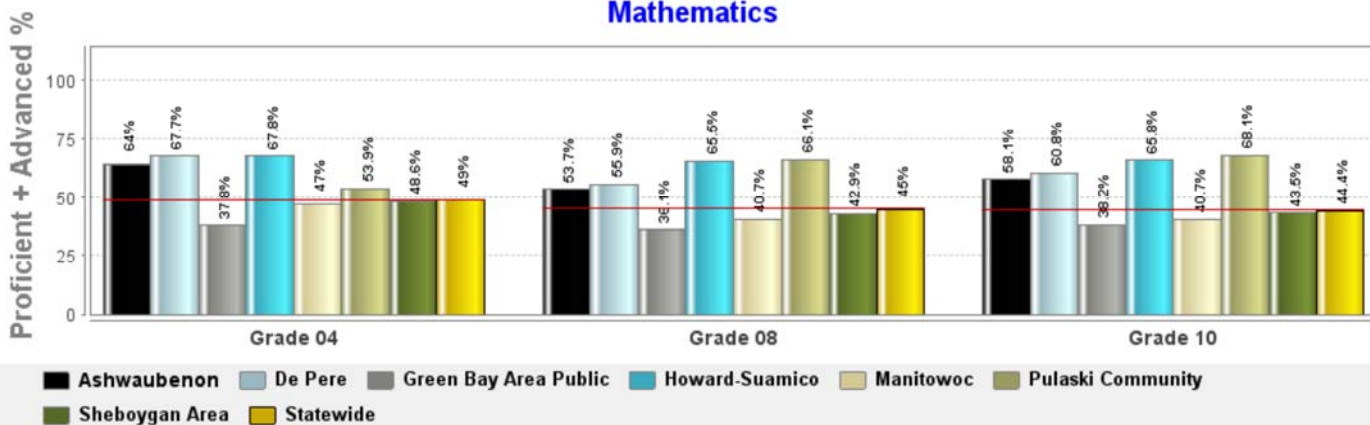

Language Arts



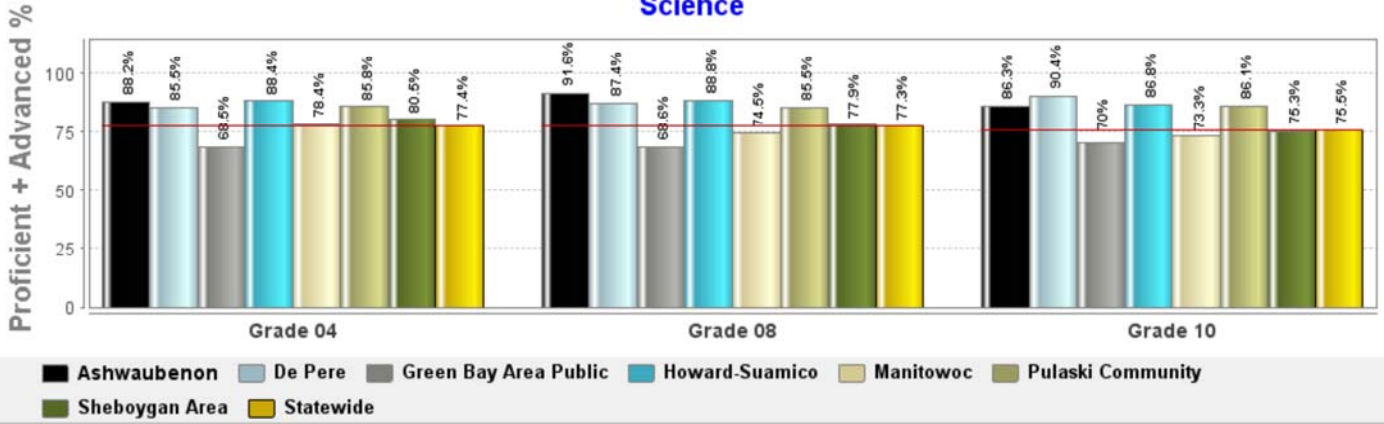

Mathematics



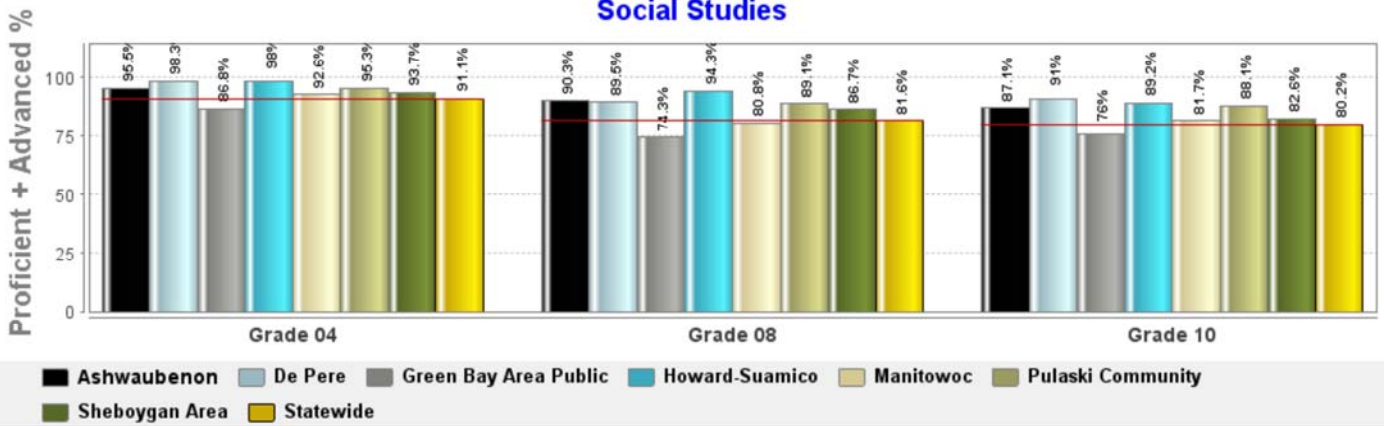

High School Completion, Post-graduation Plans

High School Completion - Legacy Rates (by age 21)

Beginning in 2009-10, the Wisconsin Department of Public Instruction (DPI) began reporting high school completion rates using the adjusted cohort rate formula. Adjusted cohort rates provide information about the number and percentage of students who earn a high school completion credential within a amount of time (four, five, or six years). DPI reported legacy high school completion rates through 2011-12. Legacy rates provided information about the number and percentage of students who earned a high school completion credential by age 21 in any given year. 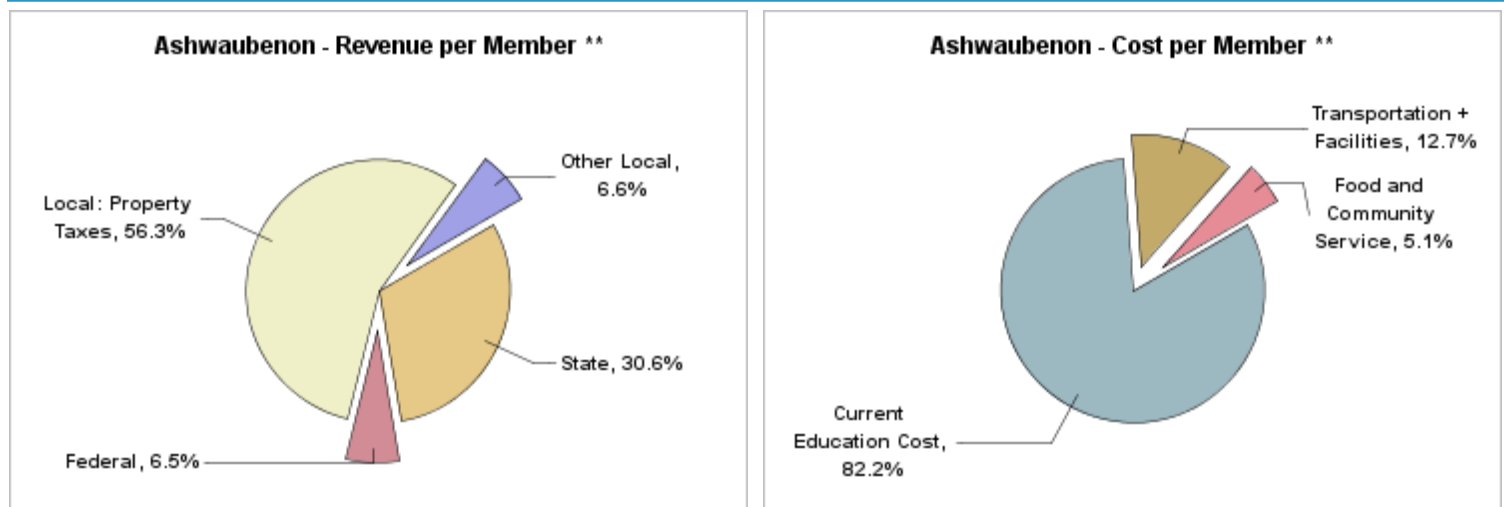
